The Tadiran AIROW, converts moisture (H2O) and Oxygen (O2) into Hydrogen Peroxide (H2O2). Hydrogen peroxide is capable of effectively treating the polluted air in the air-conditioned space. The Hydrogen Peroxide destroys bacteria, viruses and mold when emitted into the air-conditioned space, striking the perfect balance between safety and efficiency. The principle of operation is based on the formation of an electric field between a medical needle located in the center of the device and a metal cylinder that surrounds the inside of the device. The device includes an automatic needle cleaning mechanism that operates when the electronic circuit detects the need for cleaning. You will hear a clicking sound when the automatic cleaning mechanism is activated.



HOW TO OPERATE THE DEVICE?



Device Activated

The device operates when it is connected to the power supply, and immediately starts purifying the air entering in the airconditioned space.



Device Adjust

When activated, a **green LED** indicator inside the unit lights up to indicate the correct operation of the device. A **red LED** indicates a malfunction.



INSPECTION PRIOR TO INSTALLATION

After carefully opening the carton, unpack and inspect your Tadiran AIROW. Check the following:

LOCATION OF THE TADIRAN AIROW 1"

This section provides instructions on where to locate the Tadiran AIROW within an HVAC indoor unit.

- Solution Location The Tadiran AIROW is installed inside the indoor air conditioning system.
- Installation Direction The device is to be installed either in the return air side ,the air supply outlet of the air conditioner ductwork, or in the indoor unit between the filter and coil where the air flows through the Tadiran AIROW unit in the arrow direction.
- Environmental Conditions To assure proper operation, verify that the temperature surrounding the device is within 23°F -131°F and relative humidity is kept under 20% to 90%, <u>Non Condensing</u>.
- **Device Footprint** The footprint of the device is 5.3 x 4.1 inch.
- Clearance Allow 2-inch clearance for air inlet and outlet at both device's openings. Ensure the surface area of installation is free of dust, cables, and any other interference.
- Air Flow Velocity To assure proper operation, verify the air velocity through the device will be 320 ft/min or above.

Safety Hazard – Please NOTE!

Disconnect the air conditioner and the Tadiran AIRROW from the mains supply before performing the installation or before servicing the device.



INSTALLATION STEPS

TADIRAN AIROW 1™

Connect the white connector of the DC Power Supply cable to the Tadiran AIROW DC Power Connector.

NOTE: To stop the appliance operation, disconnect the DC power supply.

Following is a diagram of the electrical connections, describing the Tadiran AIROW connections to the electrical box. In order to power the Tadiran AIROW only when the indoor fan is on, connect the power supply input to the indoor unit fan control. To disconnect the unit from the power supply, disconnect the DC power white connector from the Tadiran AIROW unit.

Two magnets are attached to the base of the unit. Mount the Tadiran AIROW to a metal surface using this **easy-to-install** option.

PLUG & PLAY

Use this installation option where the duct wall is coated with insulation material or where it is required to locate the device closer to center of the air flow, for the purpose of obtaining the necessary air velocity of 320 ft/min.



Mount the Tadiran AIROW on the bracket.

To install the Tadiran AIROW on a blower housing (inside the IDU), refer to the drawing below.
